The aim of the research was the *in vivo* evaluation of dual function topical product :

1) safety and redness reduction efficacy of fluid foundation containing anti-inflammatory tetrapeptide and *Laminaria ochroleuca* extract

2) camouflage properties for skin with redness, dilated capillaries, prerosacea sympthoms – spherical ultrafine monosized beads (Polymethyl Methacrylate)

Group of patients Application n = 29

> Instrumental evaluation n = 10

volunteers with dilated capillary skin, aged 24-58 years

every day (min. 1 per day) for 2 weeks

skin erythema level
VISIA System, Canfield

 coverage and camouflage efficacy after 1 aplication photographic imaging system Foto Finder

Self-assessment questionnaire

- safety
- * visibility of erythema
- * visibility of dilated capilaries
- corrective properties

Results

In vivo study

Safety	Good to	Good tolerance of the tested formula by 97% of patients	
Self-assessment questionnaire	93%	the formula reduces skin redness	
	93%	the product alleviates irritation	
	93%	application is easy and convenient (applies evenly – no streaks)	
	90%	wish to use this product in the future	


Results




